### One-Year Limited Warranty

*What Is Covered:* Epson America, Inc. ("Epson") warrants to the original retail purchaser of the Epson product enclosed with this limited warranty statement that the product, if purchased new and operated in the United States, Canada, or Puerto Rico will be free from defects in workmanship and materials for a period of One (1) year from the date of original purchase. For warranty service, you must provide proof of the date of original purchase.

*What Epson Will Do To Correct Problems:* If your product requires service during the limited warranty period, please call the Epson Connection<sup>SM</sup> at the number on the bottom of this statement and be prepared to provide the model, serial number, and date of original purchase. An Epson service technician will provide telephone diagnostics to determine whether the product requires service. If the product requires service, Epson will, at its option, repair or replace the defective unit, without charge for parts

or labor. When Epson authorizes an exchange for the defective unit, Epson will ship a replacement product to you, freight prepaid, so long as you use an address in the United States, Canada, or Puerto Rico. You are responsible for securely packaging the defective unit and returning it to Epson within Five (5) working days of receipt of the replacement.
