Limited Support: Printer drivers do not interfere or disrupt any accessibility features. Tested with Windows Accessibility Options. Magnifier cannot be used when installing Reference Guide; Screen Reader cannot read all slider bars in Driver UI.

Support: panel buttons on product are large and easy to access. Assistive Technology is not required to attach to this product. Users with visual disability may need to install AT in the host PC.

No timed responses are required.

NA - Buttons on the product can be distinguished without activation. All buttons can be activated by one hand and require pressing to activate functions. Key repeat is not required. There are no locking or toggle keys or buttons for activating function.

No biometric forms used for user identification.

No auditory output is provided.

No voice output is provided.

Support: Drivers use text, graphics and color to convey information.

Support: No user customization options are provided.
